In consideration of the acceptance of this application by the Company and the rendering of such service, the undersigned agrees to be bound by Company's Rules and Regulations governing service as they may be changed from time to time by the Company, and to pay for such service in accordance with such rules and regulations and the applicable rates for such service now in effect or as the same may lawfully be amended or changed from time to time; and to permit the Company, its agents or employees, to enter Customer's premises at all reasonable times for all purposes necessary or incident to the rendition of such electric service.

The undersigned grants the Company a lien on the premise served by the Company for unpaid electric service and costs of collection including attorney fees and authorizes the Company to record a notice of lien in the event of a default. This lien may be foreclosed in the manner provided for mortgages under Utah law. The undersigned further agrees to make no changes or alterations in the electric line now serving or hereafter to be installed to serve the above premises, and not to build nor permit to be built any building or improvement (excepting landscaping, walks and driveways) over, across or under said electric line, and not to do nor permit to be done anything which will in any way damage or render said electric line unsafe, and that if any of the foregoing have been or are done, the Company, upon discovery thereof, may refuse or discontinue service until the condition is rectified at the cost of the undersigned.
